**Article 5.** The Fund's subscribed capital is three billion, nine hundred and thirty-seven million, five hundred thousand ( USD 3.937.500.000), distributed as follows:

- Bolivia: three hundred twenty-eight million one hundred twenty-five thousand United States dollars (USD 328,125,000);
- Colombia: six hundred fifty-six million two hundred fifty thousand United States dollars (USD 656,250,000);
- Costa Rica: six hundred fifty-six million two hundred fifty thousand United States dollars (USD 656,250,000);
- Ecuador: three hundred twenty-eight million one hundred twenty-five thousand United States dollars (USD 328,125,000);
- Paraguay: three hundred twenty-eight million one hundred twenty-five thousand United States dollars (USD 328,125,000);
- Perú: six hundred fifty-six million two hundred fifty thousand United States dollars (USD 656,250,000);
- Uruguay: three hundred twenty-eight million one hundred twenty-five thousand United States dollars (USD 328,125,000);  
and
- Venezuela: six hundred fifty-six million two hundred fifty thousand United States dollars (USD 656,250,000).
