Notification pursuant to Article XVII of the Agreement

Correction in the English version of Table 1 of the Agreement

The Depositary, with reference to depositary notification Migratory Waterbirds No. 01/2016 of 9 February 2016, communicates the following.

The AEWA Secretariat has drawn the attention of the Depositary to an error in the English text on page 54 of Table 1 of the Agreement. On page 54 the last (third) population of *Lymnocyptes minimus* (Jack Snipe) has to be moved down as second population of *Actitis hypoleucos* (Common Sandsniper).

In the French version of Table 1 of the Agreement this is correct.

The Depositary transmits herewith the relevant page as well as Table 1, as amended, in the English version.
