SECOND PROTOCOL OF AMENDMENT TO THE AGREEMENT BETWEEN

COMMISSION AND A NORTH AMERICAN DEVELOPMENT BANK

The Parties to the Agreement between the Government of the United Mexican States and the Government of the United States of America Concerning the Establishment of a Border Environment Cooperation Commission (BECC) and a North American Development Bank (NADB) signed in Washington and Mexico City on November 16 and 18, 1993, respectively, and amended by a Protocol of Amendment signed by the parties on November 25 and 26, 2002, hereinafter the "Charter".

**CONVINCED** of the importance of continuing to conserve, protect and enhance the environment of the border region through binational cooperation in order to achieve sustainable development for present and future generations;

**RECOGNIZING** the significant work carried out by BECC and NADB in the development and financing of environmental infrastructure in the border region over the past twenty years;

**TAKING INTO CONSIDERATION** the increasing institutional integration of BECC and NADB, including the establishment of a single Board of Directors for both organizations by the 2002 Charter amendment and Board Resolution 2014–19 on "Institutional Integration," which resolved to achieve the juridical and organizational integration of the institutions under the umbrella of NADB; and

#### **CONSIDERING** the Charter should be amended for the purposes of:

- Transforming the BECC into a standing subsidiary component of NADB that is a fully integrated part of NADB, while preserving its purpose, functions, and operations as established by the Charter;
- Achieving the full juridical, operational, and budgetary integration of BECC and NADB, under a unified management structure;
- Streamlining the core project development and implementation functions and increasing organizational efficiency while preserving the environmental mandate, purposes, functions, geographic jurisdiction, and binational presence currently established by the Charter;
- Establishing the position of Chief Environmental Officer as a key position within NADB to ensure that the purpose, functions, and operations of the BECC are preserved and that the environmental integrity of projects financed by NADB is maintained;
- Modifying the term of the NADB Managing Director and Deputy Managing Director from five to four years and allowing the Board of Directors to renew such term or terms for one additional period of four years;
- Clarifying the grant-making and technical assistance authority of NADB;

Have agreed to the following:

The Charter is amended by replacing the text in its entirety with the text contained in Appendix I hereto, which shall be an integral part of this Protocol.

This Protocol shall enter into force thirty (30) days after the date of the last Note in an exchange of diplomatic notes between the Parties, in which each Party notifies the other that it has completed its domestic legal procedures for entry into force of the Protocol.

IN WITNESS WHEREOF the undersigned, being duly authorized thereto, have signed this Protocol.
