

The Embassy of the United States of America presents its compliments to the Ministry of Foreign Affairs of the Republic of Korea and refers the Ministry to the Air Transport Agreement between the Government of the United States of American and the Government of the Republic of Korea, signed at Washington June 9, 1998.

In light of recent discussions between the two governments concerning removal from the Agreement of provisions relating to regulation of computer reservation systems, the Embassy proposes that Annex III to the Agreement be deleted. If the Ministry concurs with this proposal, the Embassy further proposes that this note and the Ministry's affirmative note in reply shall constitute an agreement on this subject which shall enter into force on the date of the Ministry's note in reply.
