DECISION NO. 1/2006DECISION ON FURTHER IMPROVEMENT OF PREFERENTIAL REGIME IN AGRICULTURAL
PRODUCT

THE JOINT COMMITTEE,

Having regard to the Free Trade Agreement between the Republic of Turkey and the State of Israel (hereinafter referred to as "the Agreement"), signed in Jerusalem on 14 March 1996, Protocol A of this Agreement and in Particular Article 9.3 to the Agreement and Articles VI and VII of Protocol A;

Having regard to the Decision No: 98/1 on the Rules of the Procedure of the Turkey-Israel Joint Committee, particularly Article 4 and 6 thereof;

Having regard to the common desire to promote the agricultural trade between Turkey and Israel, corresponding to the letter and spirit of the Agreement;

HAS DECIDED AS FOLLOWS:

Article 1

The Turkish Party grants additional and new concessions on imports of the below-mentioned agricultural products originating in the State of Israel within the context of the modalities indicated therein;
