# AGREEMENT FOR THE ESTABLISHMENT OF A JOINT COMMISSION OF COOPERATION BETWEEN THE GOVERNMENT OF THE REPUBLIC OF SOUTH AFRICA AND THE GOVERNMENT OF THE REPUBLIC OF RWANDA

### **PREAMBLE**

The Government of the Republic of South Africa and the Government of the Republic of Rwanda (hereinafter jointly referred to as the "Parties" and in the singular as a "Party");

CONSCIOUS of the bonds between the two countries and of the necessity to promote and strengthen bilateral relations and other forms of cooperation;

FURTHER TO the signing in Kigali on 17 December 1999 of a General Agreement on Bilateral Cooperation between the Government of the Republic of South Africa and the Government of the Republic of Rwanda;

**DESIROUS** to provide in more detail for the composition, procedures, functions, financial and other arrangements of the South African/Rwandan Joint Commission of Cooperation;

**HEREBY AGREE as follows:** 

# Article 1 ESTABLISHMENT OF THE JOINT COMMISSION

By virtue of Article 9 of the said General Agreement on Bilateral Cooperation the Parties established a South Africa/Rwanda Joint Commission of Cooperation (hereinafter referred to as the "Joint Commission").

# Article 2 PURPOSE OF THE JOINT COMMISSION

The purpose of the Joint Commission shall be to seek the ways and means of promoting and enhancing cooperation between the Parties in the agricultural, cultural, economic, political, security, social and technical fields, and to coordinate initiatives in this regard as well as to facilitate contact between the civil and private sector structures of the Parties.

# Article 3 COMPOSITION AND STRUCTURE OF THE JOINT COMMISSION

 The Joint Commission shall be presided over by the Ministers of Foreign Affairs of the Parties.
