**PREAMBLE**

The Government of the Republic of South Africa and the Government of the Republic of Botswana (hereinafter jointly referred to as the "Parties" and in the singular as a "Party");

**DESIROUS** to consolidate and strengthen the bilateral ties and reciprocal understanding between the Parties;

**CONSCIOUS** of the desirability of promoting to the greatest possible extent the mutual knowledge, experience and understanding of their respective human and development needs in the fields covered by this Memorandum of Understanding hereinafter referred to as the "MOU", by means of cooperation between the parties;

**CONSIDERING** the mutual interest of the Parties in promoting closer relations at Provincial and Local spheres of government and strengthening of their respective services;
