Honourable Minister,


I have the honour to address you, in relation to the Agreement dated November 1st, 1996, establishing the Mixed Commission between the Argentine Republic and the Republic of Trinidad and Tobago.

In this respect, and for the purpose of making the operations of the Mixed Commission more flexible, it is proposed that the Agreement dated November 1st, 1996, establishing the Argentina/Trinidad and Tobago Mixed Commission be amended to provide for meetings to be chaired by high-level officials from both Parties, other than Ministers of Foreign Affairs, Secretaries of State or Permanent Secretaries.

It is further proposed that the Agreement establishing the Argentina/Trinidad and Tobago Mixed Commission be amended to provide for the date, place and agenda for consultations to be determined between the Parties through diplomatic channels.

If the above mentioned amendments are acceptable to the Government of the Republic of Trinidad and Tobago, I have the honour to propose, on behalf of the Government of the Argentine Republic, that this Note and your Reply stating your consent, shall constitute an Agreement between our two States which shall enter into force on the date of your Note of Reply.

I avail myself, Honourable Minister, of this opportunity to renew to you the assurances of my highest consideration.
