### Excellency,

I have the honour to inform you that, with a view to further strengthening the traditional links of friendship and co-operation which unite the Republic of Trinidad and Tobago and the Argentine Republic and promoting the development of political, economic, commercial, technical, scientific and cultural relations between the two countries, and taking into account the adherence of both countries to shared principles and, in particular, their commitment to the defence of human rights and the consolidation of democracy in the hemisphere, the Government of the Republic of Trinidad and Tobago wishes to conclude with the Government of the Argentine Republic an agreement to establish a Trinidad and Tobago/Argentina Mixed Commission.

The objectives of the Mixed Commission, shall, inter alia, be:

- to consider the international political and economic situation, taking into account their full support for the consolidation of democracy in the region and with a view to promoting their peoples' economic development, international co-operation and the observance of international law;
- to analyse trade and economic relations between Trinidad and Tobago and Argentina, and to promote measures to increase and diversify such relations;
- to promote technical and scientific co-operation between the two countries and to put forward proposals aimed at making such co-operation more effective in areas regarded as being of priority by both Governments;
- to evaluate cultural co-operation between Trinidad and Tobago and Argentina, and to consider initiatives which will contribute to its enhancement.

The delegations to the Mixed Commission shall be presided over by the Minister of Foreign Affairs of the Republic of Trinidad and Tobago and the Minister of Foreign Affairs, International Trade and Worship of the Argentine Republic. Subject to the agreement of the two Parties, the chairmanship shall be delegated to the Permanent Secretary of the Ministry of Foreign Affairs of the Republic of Trinidad and Tobago and to the Secretary of State of Foreign Relations and Latin American Affairs of the Ministry of Foreign Affairs, International Trade and Worship of the Argentine Republic.

Representatives of the private sector may be included in the delegations of both countries, especially members of the commercial and industrial sectors whose initiatives may help to enhance the bilateral exchange.

The Mixed Commission shall meet once every two years in regular sessions, alternately in each country, and in special session when the two Parties so agree.

The present Agreement shall be of indefinite duration. Any one of the Parties may terminate this Agreement by giving six months' notice in writing through diplomatic channels.

If the aforementioned stipulations are acceptable to the Government of the Argentine Republic, I have the honour to propose, on behalf of the Government of the Republic of Trinidad and Tobago, that this Note and Your Excellency's Note in reply stating approval, shall constitute an Agreement between our two Governments which shall enter into effect on the date of Your Excellency's Note in reply.

I take this opportunity to renew to Your Excellency the assurances of  $my\ highest\ consideration.$
