Madam Minister:

I have the honor to refer to the Letter of Agreement on International Narcotics Control and Law Enforcement between the Government of the United States of America and the Government of the Argentine Republic, signed in Buenos Aires on September 17, 2004.

This Letter of Agreement has been designed to enhance the capability of the Government of the Argentine Republic to fight drug trafficking and related crimes such as money-laundering, transnational organized crime, and corruption. Toward that goal, the Government of the United States of America and the Government of the Argentine Republic shall take actions and commit resources on an annual basis as authorized by their respective legislative processes to support the Letter of Agreement.

In that regard, I have the further honor to propose that our two governments agree to amend the Face Sheet Amendment identifying funds for the Northern and

Northeastern Border Task Forces and other areas as agreed upon by our two governments, in order to obligate additional funds to provide further assistance.

If the above proposal is acceptable to the Government of the Argentine Republic, this Note and your return Note and signature on the Face Sheet Amendment shall constitute an Amendment between our two Governments, which shall enter into force on the date of your Note in reply.

Accept, Madam Minister, the renewed assurances of my highest consideration.



