**Executive Arrangement
between
the Government of the Republic of Poland
and
the Government of New Zealand
concerning
the Agreement on a Working Holiday Scheme between the Government of
the Republic of Poland and the Government of New Zealand**

The Government of the Republic of Poland and the Government of New Zealand, on the basis of Article 2 and Article 6 of the Agreement on a Working Holiday Scheme between the Government of the Republic of Poland and the Government of New Zealand, signed at Warsaw on 9 May 2008, hereinafter referred to as the “Agreement”, have come to the following understanding:

PARAGRAPH 1

1. Subject to compliance with the conditions of the Agreement, New Zealand will issue to citizens of the Republic of Poland up to 100 visas per one calendar year.

2. Subject to compliance with the conditions of the Agreement, the Republic of Poland will issue to citizens of New Zealand up to 100 visas per one calendar year.

PARAGRAPH 2

The Government of the Republic of Poland and the Government of New Zealand may at any time reach an understanding, through an exchange of diplomatic notes, on a different number of visas to be issued under the Agreement in one calendar year.

PARAGRAPH 3

1. This Arrangement will come into effect on the date of entry into force of the Agreement.
2. This Arrangement will end upon termination of the Agreement.
