MEMORANDUM OF UNDERSTANDING  
BETWEEN THE GOVERNMENT OF THE  
ARGENTINE REPUBLIC  
AND THE GOVERNMENT OF AUSTRALIA  
ON COOPERATION IN THE FIELD OF EDUCATION AND  
TRAINING

Guided by the desire to enhance the friendly bilateral relations between both countries in the field of education and training, and appreciating the importance of education as a factor of economic development, as well as a means for further cultivating the ties between their peoples, the Government of the Argentine Republic and the Government of Australia (herein referred to as “the Parties”) record the following understandings:

Paragraph 1

This Memorandum of Understanding provides the framework within which programmes of cooperation in education and training are to be jointly considered between the Parties on the basis of reciprocity and mutual benefit.

Paragraph 2

The Parties will endeavour to encourage and facilitate, as appropriate, the development of contacts and cooperation between government agencies, educational institutions, organisations, and other entities of Argentina and Australia and the conclusion of further arrangements between such bodies for the conduct of cooperative activities.

To this end, each Party may:

(a) facilitate the exchange of academic staff and students between recognised schools and institutions of vocational and higher education;

- (b) encourage mutual assistance and exchange of information in areas of interest in schools, vocational and higher education;
- (c) facilitate the organisation of relevant specialised exhibitions and seminars;
- (d) support the development of collaborative training, joint research, technology transfer, and joint ventures between appropriate authorities and institutions;
- (e) promote the development of joint activities leading to the exploitation of information technology, especially the Internet, in the field of education;
- (f) arrange other forms of education and training cooperation as may be mutually determined.

### Paragraph 3

The costs of cooperative activities under this Memorandum of Understanding will be funded as mutually determined and will be subject to the availability of funds.

### Paragraph 4

(a) This Memorandum of Understanding will come into effect from the date of its signature.

(b) This Memorandum of Understanding may be terminated at any time by either Party giving notice in writing of its intention to do so to the other Party. The termination will come into effect one month after notice is given.

(c) In the event of the termination of this Memorandum of Understanding, the provisions hereunder will continue to be in effect until such time when the implementation of any procedures, plans and programmes of cooperation made thereunder have been carried out to their completion, unless otherwise arranged.

d) This Memorandum of Understanding may be reviewed or modified by mutual consent. Any alteration or modification of this Memorandum of Understanding may be done by an arrangement in writing between the Parties.


(e) This Memorandum of Understanding is to be in effect for five years, and after the expiry of that time, unless otherwise arranged between the Parties, it will come into effect for another period of five years.

**Paragraph 5**

Both Parties will settle amicably, and without unreasonable delay, by consultation any differences arising in relation to this Memorandum.


