Excellency,

I have the honour to refer to the Aide Memoire concerning the future civil aviation policy for Newfoundland after union with Canada which was presented to you on February 1, 1949.

As indicated in this Aide Memoire, the Canadian Government proposes that, under the present arrangements, the traffic rights at Gander for Air France should terminate when Newfoundland joins Canada. However, in order to provide a longer period of time for Air France to adjust their bookings and to carry out any changes in administrative planning which may result from the termination of their traffic rights at Gander, the Canadian Government will extend until June 30, 1949, the present operating rights which Air France enjoys at Gander. This is purely a transitional arrangement and after June 30, 1949, the Canadian Government will consider that Air France may exercise only transit rights at this airport. In addition, to conform with Canadian laws, it will be necessary for Air France to obtain a temporary permit immediately from the Air Transport Board for the period of this extension.

You will appreciate that the Canadian Government would prefer to formalize this arrangement by an exchange of notes. If the foregoing is acceptable to the Government of France, this note and your reply thereto accepting this proposal shall be regarded as a temporary understanding between the two Governments concerning this matter.

Accept, Excellency, the renewed assurances of my highest consideration.
