My dear Secretary of State,

The Government of Canada, having designated Canadian Pacific Air Lines to operate air services on routes between Canada and the South Pacific Region, propose that the agreement contained in the Exchange of Letters between the Secretary of State for Dominion Affairs and the High Commissioner for Canada in the United Kingdom dated the 31st January, 1947, and the 1st February, 1947, should be amended so as to provide:-

- (a) that the rights granted under the said Exchange of Letters shall be withdrawn from Trans Canada Airlines and accorded to Canadian Pacific Air Lines;
- (b) that the rights thus accorded to Canadian Pacific Air Lines shall be exercised in accordance with, and subject to, the Agreements concluded between the Government of Canada and the Government of Australia and between the Government of Canada and the Government of New Zealand.

If these proposals are acceptable to His Majesty's Government in the United Kingdom, I suggest that this letter and your reply should be regarded as constituting an agreement between our two Governments amending the Exchange of Letters dated the 31st January, 1947 and the 1st February, 1947.
