ANNEAURE TO THE AGREEMENT BETWEEN CANADIA AND THE UNITED KINGDOM FOR THE PURCHASE OF CANADIAN WHEAT WHICH WAS SIGNED AT OTTAWA JULY 24, 1946

The Government of Canada and the Government of the United Kingdom,

Considering that it is provided under Clause 5 of the above-mentioned Agreement that detailed terms and conditions of such matters as carrying and forwarding charges, grades, routeing of shipments and all other matters incidental to the fulfillment of the Agreement shall be discussed and settled from time to time and incorporated in documents to form annexures to the Agreement,

Have agreed that the following document shall hereafter form Annexure I to the said Agreement:

ANNEAURE I

- 1. In arriving at the division of Agreement quantities (Clause 1 (a) (i) to (iv)) between wheat and wheat flour there shall be deducted from the actual quantity of wheat booked by mills in each crop year for the United Kingdom an amount in bushels regarded as equivalent to milling offals retained in Canada.
- 2. This net amount of wheat represented in flour bookings (i.e. after the amount in bushels represented by offals retained in Canada has been deducted) will then be deducted from the total wheat quantity for the crop year in order to arrive at the amount of wheat to be shipped as such under the Agreement for that crop year.
- 3. This interpretation will apply in the crop years 1946/47, 1947/48, 1948/49 and 1949/50.
- 4. It is understood that the quantities set forth in Clause 1(c) of the Agreement shall be interpreted as "flour" and not "wheat for flour". In the crop year 1946/47 the interpretation contained in Clauses 1 and 2 of this Annexure shall apply only to the maximum of 640,000 tons of flour.

- 5. It is further understood that within the quantitative flour limits wheat used in milling for United Kingdom account shall be provided at the Agreement wheat price.
- 6. It is agreed that the date for completion of the negotiation of the flour quantity for 1948/49 be amended from 1st July, 1947, to 1st May, 1948, and similarly for 1949/50 from 1st July, 1948, to 1st May, 1949.
