If the Canadian Government grants permission for the use of the range, the Commanding Officer, Naval Air Station, Grosse Isle, Michigan, will be designated as the United States Navy representation to coordinate use of the range.

The Secretary of State for External Affairs presents his compliments to His Excellency the Ambassador of the United States of America, and with reference to Mete No. 74 of September 25, 1952, from the Embassy, has the hanour to state that the Canadian Government is pleased to extend an invitation for United States Mayal Aircraft to make use of the Gunnery Range recently established by the Royal Canadian Air Force on Lake Huran.

The location of the new range differs slightly from the location described in the Embassy's Note No. 74. The Boundaries of the new Range are as follows:

"Commencing at a point on the International Boundary at Latitude 45°58' M, Longitude W. 52°08'. Thence on a bearing of 11°52', a distance of 9.5 miles. Thence on a bearing of 101°58', a distance of 10 miles. Thence on a bearing of 191°58', a distance of 30 miles. Thence on a bearing of 281°52', a distance of 10 miles. Thence on a bearing of 281°52', a distance of 11 miles to the International Boundary. Thence north-easterly and north-westerly along the International Boundary to the point of commencement.

All bearings are true and distances shown are statute miles."

Three copies of the Metice to Mariners defining the new Firing Range are attached for the Embassy's information.

The range has been established under the ecutrol of the Department of Mational Defence, which will be responsible for the issuing of any necessary warning and netices to ships and aircraft in the area. The Camadian Government agrees to the designation of the Commanding Officer Haval Air Station, Gresse Isle, Michigan, as the United States Mavy authority responsible for ec-ordinating use of the range.

The following restrictions and conditions apply to the use of the range:

- No restriction will be placed on the movement of any sireraft over the area or any surface vessel on it. It will be the responsibility of the commanders of aircraft engaged in gunnery exercises to operate in parts of the range where there will be no possible hazard to surface vessels or other aircraft.
- 2) The notices to airmen, mariners and fishermen which will be issued by the Canadian Authorities will not restrict traffic in the area in any way, but will merely serve as a notification that practice firing will take place in the area.

- (5) He targets will be dropped which will be a hazard to navigation and no weapons larger than 80mm. camen will be used.
- (4) Practice gunnery on the range will be conducted in accordance with regulations is sued by the Royal Genedian Air Force for the use of the range.
- (5) This invitation is extended to the United States Government for the period ending on December \$1, 1954, and may be renewed by mutual agreement.
- (6) The United States Government undertakes to make reasonable provision for the disposition of claims and for the satisfaction of any proper claims arising out of damage or injury to persons or property occurring in the territory of Cameda in connection with the use of the range by United States Aircraft.

The Canadian Government wishes to be informed if it is the desire of the United States Government to accept the invitation for the use of the range subject to the canditions nated above.
