**PROTOCOL**  
**on Amending the Treaty on the Eurasian Economic Union of**  
**May 29, 2014 and Certain International Treaties Forming Part of**  
**the Law of the Eurasian Economic Union with Regard to the**  
**Accession of the Kyrgyz Republic to the Treaty on the Eurasian**  
**Economic Union of May 29, 2014**

The Republic of Armenia, the Republic of Belarus, the Republic of Kazakhstan, the Russian Federation and the Kyrgyz Republic, being guided by the second indent of Article 1 of the Treaty on the Accession of the Kyrgyz Republic to the Treaty on the Eurasian Economic Union of May 29, 2014 signed on December 23, 2014, and in accordance with Article 8 of the said Treaty,

have entered into this Protocol as follows:

Article 1

In connection with the accession of the Kyrgyz Republic to the Treaty on the Eurasian Economic Union of May 29, 2014, the Treaty on the Eurasian Economic Union of May 29, 2014 and certain international treaties listed in the Annex to the Treaty on the Accession of the Kyrgyz Republic to the Treaty on the Eurasian Economic Union of May 29, 2014 signed on December 23, 2014 (as amended by the Protocol on Amending the Treaty on the Eurasian Economic Union of May 29, 2014 and the International Treaties Concluded in the Establishment of the Legal Framework of the Customs Union and the Common Economic Space with Regard to the Accession of the Republic of Armenia (Annex 2 to the Treaty on the Accession of the Republic of Armenia to the Treaty of the Eurasian Economic Union of May

29, 2014 signed on October 10, 2014)) shall be amended in accordance with the Annex to this Protocol which forms an integral part of this Protocol.

## Article 2

This Protocol forms an integral part of the Treaty on the Accession of the Kyrgyz Republic to the Treaty on the Eurasian Economic Union of May 29, 2014 signed on December 23, 2014.

This Protocol shall be ratified and, except for paragraphs 3 and 4 of the Annex to this Protocol, shall enter into force on the date of receipt by the depositary through diplomatic channels of the last written notification of fulfilment by the Member States of the Eurasian Economic Union and the Kyrgyz Republic of the internal legal procedures required for the entry into force of:

the Treaty on the Accession of the Kyrgyz Republic to the Treaty on the Eurasian Economic Union of May 29, 2014 signed on December 23, 2014;

this Protocol;

the Protocol referred to in the third indent of Article 1 of the Treaty on the Accession of the Kyrgyz Republic to the Treaty on the Eurasian Economic Union of May 29, 2014 signed on December 23, 2014;

paragraph 3 of the Annex to this Protocol shall enter into force after 18 months from the date of entry into force of this Protocol;

paragraph 4 of the Annex to this Protocol shall enter into force after 24 months from the date of entry into force of this Protocol.

This Protocol is executed in the city of Moscow on May 8, 2015 in a single original copy in the Russian language.
