The Embassy of Finland presents its compliments to the United Nations University and has the honour to propose the following:

The Government of Finland and the United Nations University have on February 4, 1984, entered into an Agreement (hereinafter referred to as the Host Country Agreement) on the World Institute for Development Economics Research (WIDER) (hereinafter referred to as the Institute) and on the same date signed a Memorandum of Understanding (hereinafter referred to as the Memorandum of Understanding) concerning the voluntary contribution of the Government of Finland towards the realization of the purposes and activities of the Institute and the application of certain provisions in the Host Country Agreement. The Government of Finland and the United Nations University herewith agree to modify the above-mentioned Memorandum of Understanding as follows:

The paragraph 1. a) in the Memorandum of Understanding concerning the contribution by the Government of Finland to the Endowment Fund of the United Nations University shall be deleted and replaced by the following paragraph:

1. Contribution by Finland

a) The Government of Finland has contributed 25 million US dollars to the Endowment Fund of the United Nations University. The contribution has been paid during the years 1984-89 in six instalments.

The UNU Endowment Fund, including the contribution from the Government of Finland, shall be administered in accordance with the Financial Regulations and Rules of the United Nations. The income derived from the investment of the Finnish contribution shall be used for the financing of the Institute. The Finnish contribution shall be invested together with the other funds in the UNU Endowment Fund in the global financial market with the view to maximizing the income while protecting the real value of the basic capital of the Finnish contribution. Furthermore, the United Nations University shall take all possible measures to obtain additional funds from other sources to secure the financing of the Institute.

The United Nations University shall provide the Government of Finland bi-annually with a certified financial report on the investment of the Finnish contribution as part of the UNU

United Nations University Tokyo Endowment Fund, the total income of the Institute derived from the investments of the funds earmarked for the Institute in the UNU Endowment Fund, the share of the total income corresponding the Finnish contribution, as well as the total income and expenditures in respect of the Institute. Furthermore, the United Nations University shall, on request, provide the Government of Finland with any other relevant information related to the Finnish contribution.

In case the Institute ceases to operate in Finland the use of the Finnish contribution paid to the UNU Endowment Fund will be determined jointly by the Government of Finland and the United Nations University.

In other respects the provisions of the Memorandum of Understanding signed on February 4, 1984, shall remain unchanged.

If the foregoing is acceptable to the United Nations University the Embassy of Finland proposes that this Note together with the reply by the United Nations University accepting the proposal shall constitute an agreement between the Government of Finland and the United Nations University, which shall enter into force 30 days after the date of the Note in reply.

The Embassy of Finland avails itself of this opportunity to renew to the United Nations University the assurance of its highest consideration.
