AGREEMENT BETWEEN

THE GOVERNMENT OF THE ARGENTINE REPUBLIC AND

THE GOVERNMENT OF THE KINGDOM OF NORWAY ON A WORKING HOLIDAY PROGRAMME

The Government of the Argentine Republic and the Government of the Kingdom of Norway, hereinafter referred to as "the Parties";

In a spirit of promoting closer relations of cooperation between both Parties;

Desirous of providing greater opportunities for the nationals of each country, particularly the youth, to appreciate the culture and general way of life of the other country for the purpose of promoting mutual understanding between both Parties;

Have come to the following Agreement for the implementation of a Working Holiday Programme ("the Programme") between both Parties:

Obligations of the Government of the Kingdom of Norway ARTICLE 1

The Government of the Kingdom of Norway shall, subject to Article 2, on application by a national of the Argentine Republic, issue a working holiday permit to any person who satisfies the following requirements:

- (a) is a national of the Argentine Republic with habitual residence in the Argentine Republic at the time of submitting the application;
- (b) has as his/her primary intention to holiday in the Kingdom of Norway, employment being incidental rather than the primary reason for the visit;

- (c) is aged between eighteen (18) and thirty (30) years, both inclusive, at the time of submitting the application;
- (d) is not accompanied by minors;
- (e) holds a valid Argentine passport;
- (f) has a return ticket or sufficient funds to purchase such a ticket;
- (g) has sufficient funds for his/her maintenance during the initial period of stay in the Kingdom of Norway, at the discretion of the relevant authorities:
- (h) pays the established working holiday permit application fee;
- (i) agrees to hold a valid comprehensive medical and hospitalization insurance during his/her stay in the Kingdom of Norway;
- (j) has not previously taken part in the Programme; and
- (k) undertakes to leave the territory of the Kingdom of Norway at the end of his/her stay.

A work holiday permit does not establish right of family immigration.

ARTICLE 2

The Government of the Kingdom of Norway may issue each year a maximum of three hundred (300) of the working holiday permits mentioned in Article 1 to nationals of the Argentine Republic.

ARTICLE 3

The working holiday permit shall be valid for a period of not more than twelve (12) months from the date of entry into the Kingdom of Norway. The date of entry must be within six (6) months after the working holiday permit has been granted. Registration must take place within seven (7) days after entry.

ARTICLE 4

The Government of the Kingdom of Norway shall require any national from the Argentine Republic who has entered the Kingdom of Norway through the Programme implemented under this Agreement to comply with the laws and regulations of the Kingdom of Norway and not to engage in remunerated activities that are contrary to the purpose of the Programme. Participants in the Programme shall not be permitted to engage in remunerated activities

permanently and shall not work for the same employer for more than six (6) months during their visit. They may enrol in a training or study course of up to three (3) months' duration during the course of their visit to the Kingdom of Norway.

Obligations of the Government of the Argentine Republic ARTICLE 5

The Government of the Argentine Republic, through its consular representation office in the Kingdom of Norway, shall, subject to Article 6, on application by a Norwegian national, issue a temporary visa to any person who satisfies each of the following requirements:

- (a) is a national of the Kingdom of Norway with habitual residence in the Kingdom of Norway at the time of submitting the application;
- (b) has as his/her primary intention to holiday in the Argentine Republic, with remunerated activities being incidental rather than the primary reason for the visit;
- (c) is aged between eighteen (18) and thirty (30) years, both inclusive, at the time of submitting the application;
- (d) is not accompanied by minors;
- (e) holds a valid Norwegian passport;
- (f) has a return ticket, or sufficient funds to purchase such a ticket;
- (g) has sufficient funds for his/her maintenance during the initial period of stay in the Argentine Republic, at the discretion of the relevant authorities;
- (h) pays the established visa application fee;
- (i) agrees to maintain valid comprehensive medical and hospitalization insurance during his/her stay in the Argentine Republic;
- (j) has not previously taken part in the Programme; and
- (k) intends to leave the territory of the Argentine Republic at the end of his/her stay.

ARTICLE 6

The Government of the Argentine Republic may issue each year a maximum of three hundred (300) of the visas mentioned in Article 5 to nationals of the Kingdom of Norway.

ARTICLE 7

The working holiday visa shall be valid for a period of six (6) months for multiple entries and shall authorize its holder to stay in the territory of the Argentine Republic for twelve (12) months as from the date of their the first entry.

ARTICLE 8

The Government of the Argentine Republic shall require any Norwegian national who has entered the Argentine Republic through the Programme implemented under this Agreement to comply with the laws and regulations of the Argentine Republic and not to engage in remunerated activities that are contrary to the purpose of the Programme. Participants in the Programme shall not be permitted to engage in remunerated activities permanently and shall not work for the same employer for more than six (6) months during the course of their visit. They may enrol in a training or study course of up to three (3) months' duration during the course of their visit to the Argentine Republic.

General provisions ARTICLE 9

Either of the Parties may refuse any particular application it receives.

ARTICLE 10

Either of the Parties may, according to its own legislation, refuse entry into its territory, or remove from its territory, any person participating in the Programme who do not fulfill the entry conditions or the conditions to stay in the territory.
