AGREEMENT

BETWEEN

**THE GOVERNMENT OF THE REPUBLIC OF
SOUTH AFRICA**

AND

**THE GOVERNMENT OF THE REPUBLIC OF
LIBERIA**

**REGARDING THE WAIVER OF VISA
REQUIREMENTS FOR HOLDERS OF
DIPLOMATIC AND OFFICIAL PASSPORTS**

PREAMBLE

The Government of the Republic of South Africa and the Government of the Republic of Liberia (hereinafter jointly referred to as the "Parties" and separately as a "Party");

DESIRING to facilitate the entry of citizens of the Republic of Liberia and citizens of the Republic of South Africa, who are holders of valid diplomatic and official passports into their respective countries;

HEREBY AGREE as follows:

Article 1 **COMPETENT AUTHORITIES**

The Competent Authorities responsible for the implementation of this Agreement shall be—

- (a) in the case of the Government of the Republic of South Africa, the Department of Home Affairs; and
- (b) in the case of the Government of the Republic of Liberia, the Ministry of Foreign Affairs.

Article 2 **WAIVER OF VISA REQUIREMENTS**

Citizens of the country of one Party, who are the holders of valid diplomatic and official passports in that country, may enter, sojourn and exit the country of the other Party, for a period not exceeding 90 (ninety) days, without having obtained a visa.
