AGREEMENT ON COOPERATION IN PREVENTING ILLEGAL LABOUR MIGRATION FROM THIRD STATES

The Government of the Republic of Belarus, the Government of the Republic of Kazakhstan and the Government of the Russian Federation, hereinafter referred to as the Parties,

Guided by the Agreement on a Customs Union and a Common Economic Zone of 26 February 1999,

According priority to the task of ensuring the rights and legitimate interests of nationals of the States Parties,

Regarding cooperation in preventing illegal labour migration from third States as an important area in the regulation of migration processes in the territories of the States Parties,

Based on the norms of international law and the legislation of the States Parties,

Endeavouring to create a legal framework for the cooperation of the Parties in preventing illegal labour migration from third States,

Have agreed as follows:

Article 1

This Agreement shall define the areas and forms of cooperation among the Parties in preventing illegal labour migration from third States.

This Agreement shall not apply to persons who come from a third State to the territory of one of the States Parties to seek asylum or refugee status under the procedure prescribed by the legislation of that State Party.

Article 2

1. For the purposes of this Agreement, the terms used herein shall have the following meanings:

"State of entry" shall mean the State Party into whose territory a national of a third State or stateless person travels in order to work;

"Third State" shall mean a State that is not a party to this Agreement;

"National of a third State" shall mean a national of a State that is not a party to this Agreement;

"Competent authorities" shall mean the authorities of the States Parties charged with implementing the provisions of this Agreement;

"Stateless person" shall mean a person who has no proof of citizenship in any State and who does not reside permanently in the territory of any of theStates Parties;

"Illegal labour migration" shall mean the entry into and/or stay in the territory of one of the Parties of nationals of third States or stateless persons in order to work, in violation of the
